

Once again the Montgomery Bar Association sponsored our Paralegal Celebration in July. The silent auction raised over \$500 for MCAP. 

Paul C. Troy Esq. Addresses MCPA Members Regarding Avoiding Legal Malpractice: How to Help Protect Your Firm from Professional Liability

On Thursday, November 29, 2012 at 6 p.m., the MCPA held its annual elections meeting at the Giant Community Center in Willow Grove. President Annette M. Long CRP presided over the meeting. Annette announced that \$1,000 from our successful fundraiser would be awarded to Montgomery County Legal Aid. We have three new board members: Kelly Smith, Christopher Gregg and Laura Garifo. The holiday social will feature a jewelry and handbag trunk show. We are looking for a Pierce Paralegal School student liaison and a volunteer to give out and collect nametags for each meeting. MCPA has a new gold sponsor: Morgan Wentworth

recruiters. Morgan Wentworth is sponsoring tonight's program.

Having dispensed with the announcements, Annette then turned the spotlight over to Paul C. Troy. Mr. Troy focuses his practice on professional liability; commercial, auto and general liability; and medical malpractice litigation. Mr. Troy presently serves as the Chair of the House of Delegates of the Pennsylvania Bar Association. He is a Life Fellow of the Pennsylvania Bar Foundation and served on the Board of Directors of the PBF from 1998 to 2000. He is a past President of the Montgomery County Trial Lawyers Section. He served as a Director of the Montgomery Bar Association from 1997 to 1999 and presently serves as an Officer of the MBA. At the annual meeting of the Pennsylvania Bar Institute in May, Paul Troy was elected Vice President of the Pennsylvania Bar Institute. He has previously served as Secretary and Treasurer of the PBI. Paul Troy recently presented Continuing Legal Education Seminars entitled "Avoiding Legal Malpractice" to the Bar Associations of Montgomery, Bucks and Lehigh counties. Mr. Troy teaches this program several times annually to county bar associations and law firms as part of his work with the Pennsylvania Bar Association's Professional Liability Committee.

In his presentation on "Avoiding Legal Malpractice: How to Help Protect Your Firm from Professional Liability," Mr. Troy stressed that it is not only the bottom of the barrel of lawyers who may be sued. Rather, any attorney can be sued. Common issues that cause attorney malpractice suits are: failing to file the lawsuit before the statute of limitations expires; filing suit against the wrong party; failing to keep the client's expectations under control; dabbling in types of suits with which the attorney is unfamiliar; failure to compose an engagement letter documenting the estimated length of the case, the cost of the case, and realistic estimate of the client's chances for prevailing in the suit; failing to document notification of the client that the case is not going well if the case has become a monster and the client is unlikely to prevail.

How can an attorney avoid a countersuit from a client he has taken to collections? The attorney can show the client the engagement letter documenting the estimated length of the case, the cost of the case, and realistic estimate of the client's chances for prevailing in the suit that both

attorney and client signed at the outset of the case. As cases progress, documenting advice that the client's chances are beginning to look less rosy are very helpful if the client eventually sues. The attorney may recommend that the client refer the suit to the fee dispute committee of the Montgomery County Bar. If the attorney wants to withdraw from the case due to nonpayment of fees, it is important that he ask permission of the court to do so.

Mr. Troy then spoke of the role of the paralegal in preventing malpractice suits against their firms. Paralegals facilitate communication between the client and the attorney. With that function and the attorney's permission, they can help keep the client's expectations under control. Paralegals may help to avoid missing the statute of limitations by making sure the complaint is filed early. They can use investigators to ensure they have sued the proper party. They keep track of clients' escrow accounts to verify they are being replenished in a timely manner.

Becoming a Paralegal: A New Graduate's Experience

Starting a career as paralegal is not always easy. I believed that my career as a paralegal would begin very differently and years ago. I thought I would get my start at a large law firm in Richmond, Virginia in May 2009 upon graduation from the University of Richmond. As a recent graduate who had just obtained her Bachelor's Degree in Political Science, I was disappointed to learn that the job world wasn't interested in giving me a well-paying job that required specific skill sets. After all, why then did I have a large amount of debt waiting for me to make payments on each month after graduation? Did I just waste the last four years of my life to obtain a worthless piece of paper? Without any job prospects in the Richmond area, I moved home to Pennsylvania to see if there were any opportunities for me there.

Unfortunately nothing promising came about, so I volunteered to work on a local political campaign and found a job as a receptionist at an animal hospital that was 45 minutes away from my parent's home. I swallowed my pride and decided that at least if I was going to work as a receptionist, I would be around lots of animals. As it turns out, I really liked being around animals and even considered changing career paths to become a veterinary technician. Besides enjoying spending time around animals, I learned that I have a desire to help them. I was introduced to the concept of animal rescue and I haven't looked back. I networked with people I had never met (and still have not) to assist with the rescue of animals from abusive situations. About half of the women I spoke with through animal rescue were paralegals themselves.

I sometimes wonder why so many people involved with animal rescue were in the same professional field. Perhaps it's because they're smart people who think outside the box, who understand the law and want to change it to protect those without voices. Or, it could be that they are driven individuals who are also compassionate and who work well together to accomplish a task. Whatever it is, I'd like to think that paralegals are attracted to their line of work to make some kind of difference and be a part of a team.

After almost two years working in veterinary care, I accepted a position for a small firm working as a legal secretary and marketing director. I enrolled in Villanova's Paralegal Part-Time studies program, allowing me to work full-time and attend classes in the evenings for one year. Villanova was an easy choice because it is an approved school through the American Bar Association. The ABA Certification is something many employers now look for and is becoming the standard in the paralegal profession. Last year I received an email from the Villanova director with a job positing for a large corporation that caught my eye.

The position was for an entry-level paralegal in the in-house counsel law department. I read through the posting, which outlined the duties and responsibilities required for the job. Some of the tasks looked familiar from business law class but other parts weren't as familiar to me. Nevertheless, I applied to see if it would be a good fit. Turns out, my skill sets and past experiences were exactly what the company was looking for. In a rare opportunity, the company was willing to hire a recent paralegal graduate and teach them everything they need to know to successfully do their job. The seemingly intimidating and quiet law department was filled with a nice group of people, making it easier to see myself there. To make it even better, many of them had rescued an animal or are involved with rescue. Talk about a good selling point for me. The

way I see it, the work environment is great and even during the stressful days, the professionals I work with are good people who share my interests.

My opportunity to come into the company as a new paralegal is unique. I have been given time to adjust and learn, make mistakes and do things I never knew paralegals can do. I knew very little about the stock market and now I manage all employee stock option exercises and speak with brokers daily. I knew of minute books that had to be kept for businesses but only in a minimal capacity for small business. As a large corporation, minutes are drafted frequently for different committees and I help prepare them for the minute books. Another aspect of my job that I had little familiarity with is the filing of SEC compliance documents like 8-K, 10-Q and 10-K filings.

I have been shown how to shepardize the federal regulations that apply to the SEC filings. Along with that, I assist in the preparation and circulation of questionnaires to all members of upper-management and the board of directors for the information to draft the filings. Another aspect of my job I enjoy is that I have one client -my company - and I know it well despite its expansive national and international presence. I have been able to act as a liaison between hired outside counsel and the company to manage various cases. My position as a paralegal allows me to learn often and work on a variety of projects.

Very recently I was offered a promotion to become the Corporate Paralegal for the Company. As the New Year rings in, I will begin a new path to becoming a more specialized paralegal professional. The new opportunity will allow me to gain a greater understanding and knowledge of corporate governance and executive compensation. For example, instead of helping to post materials for board meetings, I will be able to assist the Corporate Governance and Securities Attorneys to prepare the materials. I am looking forward to starting 2013 with a new focus!

My advice to new paralegals is to start small; sometimes there isn't a big break that happens just because you deserve it for earning a degree. Sometimes, it's finding ways around landing the perfect job to gain the skills you need to impress a future employer. Learning as much as you can from experiences you wouldn't normally think apply to paralegal skills may open your eyes and give you a competitive edge over other applicants.



Helpful Hints from our Colleagues

Resolve to Be Organized

With the New Year upon us, I think that many paralegals are resolving to be a little more organized in 2013. Being organized can make life easier and less stressful when your schedule gets full, and here are some simple ways that you can keep yourself organized without any hassle:

Give each item a "home," meaning everything in your work area has a place where it stays, so certain parts of your work area have the items you use for certain tasks. The reason you want everything to have a certain "home" is so that before you leave your work area every day, whatever you used can be returned quickly to its proper place, and you *never create clutter*. When you utilize this "clean as you go" method, you only need a few minutes every day before leaving work to set things right. It's great to come in to a pristine work area every morning.

Use a physical, Outlook or smartphone calendar or planner: Now this may seem like something that is common knowledge, but a lot of people use a calendar or planner and then never look at it. Putting a calendar in a place where you can see it and making sure that you look at it every day is something that you need to put in your routine. After making your coffee or before getting ready to start your day, make sure you look at the day and take note of what you need to get done. Today's Outlook and smartphone calendars have great pop-up reminder features that make appointments, reminders and tickler events a breeze to create.

Make a list for the day: After looking at your calendar, you write down tasks you need to get done or what you need to do to accomplish the tasks. Giving yourself a visual of what you need to do gets rid of the worry that you may have forgotten something or helps you remember an item that may have slipped your mind. Outlook has task functions and smartphones have apps available such as Todoist (http://todoist.com/) that keep track of your running task list.

Scan every document: Most law firms utilize a document management system. Know your firm's system inside and out. Scan and electronically file every physical document you touch. This practice reduces the amount of paper clutter in your work area and will lead to increased productivity because you don't have to hunt down lost files and documents. I have a "scan first" policy at my office- my attorneys, colleagues and clients have come to depend on me because I can locate and transmit needed documents quickly.

I hope these practices will make you an indispensable asset to your firm in 2013!
