### A Message from the President:

Every member of the MCPA who has provided their email address will be receiving an email within the next week or two. As first time users, we will all need to register our accounts. The email provided with your MCPA Membership Renewal or Application will serve as your User ID. You will be directed to the Montgomery Bar website for sign-in with instructions. Your email inbox will then receive a confirmation link so that you can set up your password and begin accessing the "Members Only" information on the MBA website.

#### As a Registered MCPA Member you will be able to:

- Register yourself and your firm attorneys for CLE's and other MBA events. (*Please note: There is now a "Paralegal" category for registration. If the "Paralegal" radio button does not appear on the page, this means that you are not eligible to register for that event).*
- Securely make payments by credit card (VISA, MC, Discover or AMEX) or by using the new "Bill me later" option. (*You will receive an invoice in the mail for payment by check*)
- Obtain free access to searchable and published *Montgomery County Court Opinions* since 1995.
- Purchase products for your attorneys and take advantage of their member discounts.
- View and download the weekly Montgomery County Law Reporter, Sheriff Sales Supplement, Tax Sale and Unclaimed Property listings on Friday's after 4 pm for the following week's issue.
- Receive important *Court Announcements*, *CLE Notifications* and *Special Event Reminders* from the MBA.
- Access nearly 200 area supplies via our new, Legal Marketplace Section (many of whom will offer preferred discounts to MBA members and their staff!);
- You will be able to access our Online Member Photo Directory and the Lawyer To Lawyer Networking Section and the ability to pay your attorneys' dues online.

We will continue our efforts to ensure a smooth transition for the listserve and look forward to working closely with the Montgomery County Bar Association!

### NFPA News - Article by Cindy Welch, NFPA Region II Director

### WHAT MAKES A GOOD LEADER?

We can all name several people, locally or nationally, who we admire for their leadership qualities, and it always interests me how they acquired those skills. Unfortunately, there's no exact recipe; 1 tablespoon of intelligence, ½ teaspoon of wit, ½ cup of respect, because none of us come to the table a blank slate. We have both personal and professional life experiences in our history so we are left to figure out what we need more of and in what quantity! Oh, yes, that'll be easy... What I can offer is some suggestions of the "ingredients" needed – the quantities will be up to you.

- THE ABILITY TO LISTEN. When someone says something, it isn't just the words they are sharing; it's a feeling or a passion or even a lack of passion. If you're unsure what the other person really means by their comments, repeat their statement back to them in your own words to see if you've got it.
- THE ABILITY TO "NOT SPEAK." What? While serving as a member of my local association and as a current member of the NFPA board, I've watched observed leaders "not speaking." This not only creates more opportunities for others to voice their opinion but it gives everyone a moment to reflect on previous discussion.
- THE ABILITY TO SHARE. No one person makes up a board or committee so when your goal is reached or the event is a success, share the accolades with the others on your team. Maybe even incorporate the royal "we" into your vocabulary now and then.
- TAKE RESPONSIBILITY. Whether you are the committee chair or the president of your board, if a project fails, take responsibility. Everyone know that typically it's not just one person's fault when an action is unsuccessful, so the members of your team will respect the fact that you are willing to step up and not point fingers at others. You and your team can dissect the situation in private so you can do a better job next time.
- BE OPEN TO IDEAS. Just because you didn't think of it first doesn't mean it isn't a great idea. Consider the new team member who makes a suggestion and three or four of the long-time members immediately shut it down "because we tried that and it didn't work." Talk it out-while it may not have been successful many years ago, that same idea might work now if tweaked a little.
- LEARN ABOUT THE ORGANIZATION. While I had been a member of my local association for over a dozen years before I became president, I was truly surprised at how much I *didn't* know about it. I made a point of visiting specialty sections I hadn't attended before, welcoming each new member (via email,) meeting the attendees as they arrived for meetings, reading and re-reading the procedures and the bylaws and helping our executive director with registration.





### WHAT MAKES A GOOD LEADER? (continued)

- TRUST IN THE OTHERS ON YOUR TEAM. Trust that since they volunteered for that job or position, that they feel they can handle their duties. Give them a chance to succeed they might surprise you. If you feel they need some assistance, give them a "buddy" on the board. Likewise, find yourself a buddy or mentor if you need help in a specific area.
- RESPECT OTHERS. There is no rule that says you have to be best friends with those on your team or even like them but you do need to respect them. Respect their ideas, their commitment to the board, and their time and efforts.
- LEAD BY EXAMPLE. Just as children learn this way, so do adults. Your respect and trust of others will be reciprocated. If you expect your team members to finish their assignments on time, then you need to do the same. The supervisors that I respected the most always got in the trenches with their employees.

Try tackling one of these attributes every month and even ask for some suggestions from your group. Make it a safe place for them to speak their mind and for you to shine as a leader.

The NFPA Pro Bono Co-Coordinators and the Pro Bono Committee are providing this webinar to assist you in your pro bono efforts and to introduce potential areas where you may find opportunities to volunteer in your community. It is NFPA policy that every paralegal contribute 24 hours of pro bono work annually. RPs are able to convert pro bono hours into CLE hours upon application.

### NFPA News - Self-Reporting of Pro Bono Hours by NFPA members

The NFPA Pro Bono Team has established an easy way for individual members to report both pro bono and community service hours electronically. Individuals simply send an email to nfpaprobono@gmail.com\_ to request the electronic form. For first requests, the individual should indicate whether they are a member of a local paralegal association or an NFPA individual sustaining member. Note that a new request/separate form is needed for acts of service for: 1) each different agency/organization during a calendar year; and 2) pro bono or community service (they cannot be reported together).

An example is volunteering for an agency where medical records were reviewed in 2011 over three non-consecutive days, as well as serving on the organization's annual fund raiser committee. The three days of pro bono service to review and summarize the medical records may be reported on thes ame form since it was for the same agency; the community service portion for the same agency would need to be reported on a separate form.

## **Meeting and Event News – January 2012 Events**

## **January Kick-off Meeting**

On January 17, 2012, MCPA kicked off a new year at Chadwick's. What a great turnout. The evening started with our President, Annette Long, welcoming our special guests, Susan Gibson from the Young Lawyers Association, George Cardanas from the Montgomery Bar Association and the current Montgomery County Bar President, Donald J. Martin, Esq.

Ms. Long then introduced Mr. Martin, who spoke shortly about his new position as President and how the past President, the Honorable Carolyn Tornetta Carluccio, left him with tough shoes to fill, as they were high and pointy. Mr. Martin, who is a past speaker at MCPA events, said "without paralegals, the legal profession couldn't function." And that the Bar Association is looking to work closely with the MCPA this year and for years to come. Mr. Martin then introduced our guest speaker and the immediate past President, Judge Carluccio.





### **January Kick-off Meeting (continued)**

Judge Carluccio was a federal prosecutor in the United States Attorney's office for 9 years prosecuting large scale drug dealers, white-collar fraud and health care crimes. She became the first woman Chief Public Defender for Montgomery County. She also served as Chief Deputy Solicitor for the County. She represented the county in litigation over the Barnes Foundation art gallery and negotiated the purchase of a \$27 million dollar building, saving taxpayers over a million dollars in broker and legal fees. Judge Carluccio has trained both attorneys and law enforcement personnel in topics including drug interdiction, asset forfeiture, money laundering white color crime, family law issues and trial advocacy. In November of 2009 she was elected to the Montgomery County Court of Common Pleas. She sat for 2 years on the Family Court Bench and was transferred to the Civil Division for 2012.

Judge Carluccio spoke about being professional and respectful in our careers. Judge Carluccio has noticed a lack of respect for the Court, as well as a lack of respect by attorneys for one another, explaining how disrespectful some attorneys have been to her as well as to other counsel in her Court. Judge Carluccio stressed the importance of raising the level of professionalism. Some keys points she brought up regarding professionalism were: a) dress for where you want to be and not for where you are; b) your hair should be neat and professional; c) answering the phone professionally says much about you as well as your firm and d) if your e-mail or voicemail messages aren't professional this speaks loudly as to you as a paralegal.

Judge Carluccio provided some common sense advice to paralegals. Your communications with clients should be in plain English and you should provide them with realistic expectations and not over-promise and under-deliver. You are a big asset to your firm if you are willing to adapt to change such as learning about e-discovery and new technology. No attorney or paralegal wants to miss an important deadline or court date. She pointed out how important it is to double check dates. You don't want to have to appear in an attorney's office and inform them that a deadline date has been missed and it was crucial to the case.

Judge Carluccio spoke on how important professional development is, and that you have taken the first step by joining MCPA - networking, mentoring and meeting new friends. She concluded by speaking of the unauthorized practice of law by paralegals. We think we are only talking to the clients and giving commonsense answers, but in fact we are actually giving them legal advice. We must be very careful with this as it most definitely can get us, as well as our attorneys, in trouble. Let the attorney give the legal advice.

We would like to thank Judge Carluccio for taking time from her busy schedule to come and give us valuable tools necessary as a paralegal. Her advice and experiences are truly enlightening.


We would also like to thank President Martin for joining us, as well as our special guests, Ms. Gibson and Mr. Cardanas.

### **Meeting and Event News – February 2012 Events**

## Mary C. Pugh, Esquire Enlightens MCPA Members Regarding Montgomery Child Advocacy Project (MCAP)

On Wednesday, February 15, 2012, the MCPA held its general membership meeting at the Giant Conference Center, Willow Grove. President Annette Long presided over the meeting. Annette briefly reviewed topics of interest such as the March 17 breakfast meeting to be held at Zoto's and the upcoming Yankee Candle Sale. She also reported that in order to sign-up for CLEs through the Bar Association, MCPA members must register by phone; the online option is not working correctly for our members at this time.

Having dispensed with the announcements, Annette then turned the spotlight over to Mary C. Pugh, Esquire and Sharon Jones, Esquire. Mary is the Executive Director of Montgomery Child

Advocacy Project (MCAP), a 501 (c)(3) organization. Mary has been recognized for her work with abused children. Sharon also works with MCAP; Annette reminded the group that Sharon was a founding member and first President of MCPA.

Mary shared the purpose of MCAP: to provide legal services to abused and at risk children in Montgomery County. One hundred forty attorneys provide pro bono services to speak on behalf of the 800 to 850 children represented by an MCAP guardian ad litem in all Montgomery County courts each year. Montgomery County is the only county in the Commonwealth to provide this level or representation to their children. Of interest, once a child is appointed a guardian ad litem in any court



proceeding, only the court is able to dismiss the guardian ad litem, this is a non-waivable appointment. Mary also shared that in some cases, a parent will name a child in a petition for a Protection From Abuse Order. Once a child is named in the petition, a guardian ad litem is appointed and the parent is unable to withdraw the petition; only the court is able to dismiss the petition after an investigation. In some cases, the MCAP advocate is the only person who believes the child.



Mary and Sharon shared stories about some of the cases they have handled. While these stories were heartbreaking, there is hope. Kate Capanear, also a Student Liaison from Lansdale School of Business, continues her Top Five column. Richard MacNabb, Student Liaison from Manor College, contributed the following article:

### Thurgood Marshall: Associate Justice Extraordinaire

February is Black History Month. In keeping with the season, I'd like to tell you about an extraordinary man I met and talked to during my Navy corpsman days at Bethesda Naval Hospital. In 1970, while attend-ing clinical laboratory school, I was selected with three other techs to be on a special care team that would help take care of a hospitalized Supreme Court justice. That justice was none other than Thurgood Marshall. Thank heavens for my history / civics class in high school, but I did go back and reread his biography. He was the court's 96th Justice and First African American Justice serving from October 1967 to Oct 1991.

During his short stay, I had the opportunity to sit with him on several occasions and he was very gracious in answering some of my questions about his experiences and achievements. Mr. Marshall was born on July 2, 1908, in Baltimore, Maryland. His father, a railroad porter, instilled in him the Constitution and the rule of law. Before his years on the court, he argued more cases before the Supreme Court than any other attorney, winning a most landmark case that changed human relationships; *Brown v. Topeka Board of Education*, 347 U.S. 483 (1954). Mr. Marshall argued that the previous decision in *Plessy v. Ferguson*, in 1896 which allowed state sponsored segregation, was unconstitutional and in violation of the Equal Protection Clause of the 14<sup>th</sup> Amendment of the U.S. Constitution. The Warren Court's decision was unanimous, 9-0.

Mr. Marshall graduated from Lincoln University, Oxford, Chester County, Pennsylvania, in 1930 and graduated first in his class from Howard University School of Law in 1933. He initially started with the NAACP, then set up private practice in 1936. He won his first major civil rights case, *Murray v. Pearson*, 169 Md. 478 (1936) which was the first to challenge the "separate but equal" doctrine which was part of the *Plessy v. Ferguson* decision. Mr. Marshall won 29 of 32 cases argued before the Supreme Court. On June 13, 1967, President Johnson nominated Marshall to the Supreme Court and confirmed by a Senate vote of 69–11 on August 30, 1967. Over the next twenty-four years, he amassed a liberal record of strong support for Constitutional protection of individual rights, especially the rights of criminal suspects.

Mr. Marshall left us on January 24, 1993, at the age of 84. He was succeeded by Associate Justice Clarence Thomas. Mr. Marshall is best remembered for his jurisprudence in civil rights and criminal justice. I will also remember him for his gracious and generous availability of his time, his jokes and funny stories, and his brilliant statesmanship. My favorite Marshall quote is "None of us got where we are solely by pulling ourselves up by our bootstraps. We got here because somebody - a parent, a teacher, an Ivy League crony or a few nuns - bent down and helped us pick up our boots." Although my father said that I argued like a Philadelphia lawyer, I didn't win one quarter of my arguments with my father that Mr. Marshall did with the Supreme Court. I regret not hiring him to plead my cases.

### Top Five... Reasons why every good lawyer needs an even better paralegal:

- **5.** We have excellent practical knowledge. A good lawyer can create an awesome game plan for getting his client out of his third DUI scot-free, but who is going to figure out the best way to fix the paper jam in the copier?
- **4. Two (or three or four) brains are always better than one.** It is crucial for a lawyer to have someone to brainstorm with. Generally, paralegals are intelligent people with a less formal education than a lawyer. We can see the ideas that are right in front of the lawyer's face.
- **3.** We play well with others. Whether through MCPA or other associations and opportunities, paralegals know how to network with other professionals in a down-to-earth manner. We also know how to help each other along the way. This means that if we do not know the answer to our attorney's problem, we probably know someone who does.
- **2. Two words: billable hours.** Especially in the smaller firms, a lawyer may work fifty-plus hours per week, but only be able to bill clients for a portion of that time. A good paralegal can perform a lot of the same tasks as a lawyer; (s)he can take on the other responsibilities so the attorney can get back to focusing on those precious billable hours.
- **1. Every "Great" needs a right-hand person.** As with any support position, we are here to help. An attorney should be able to go to his paralegal and ask for his/her help on almost any project. Most of us are clever self-starters who enjoy earning new responsibilities and mastering new tasks. We *want* to help; otherwise, we would have picked a different profession.




