PUBLIC SERVICE ANNOUNCEMENT for notary reappointments or those wishing to become new notaries:

Act 119 of 2014 removed the requirement for endorsement from the Notary Public Law. Act 119 was signed into law on July 9, 2014 and will become effective on January 5, 2015. Applications for appointment as a notary public submitted to the Department of State on or after January 5, 2015, will not be required to bear the endorsement of a state Senator.

We're pleased to announce the Department of State's new Online Notary Public Application System. This new tool will allow Pennsylvania notaries public and prospective notaries public to apply for and renew their notary commissions in an efficient paperless process. This new approach will simplify handling, thereby reducing the expenditure of tax dollars, eliminate paperwork, simplify the payment procedures and enable better customer service to notaries. The Online Notary Public Application System will require the same information currently required as part of the paper application. APRIL'S CLE RECAP

Personal Injury Law, Criminal Law, Litigation Procedural Issues and Ethics

Thursday, April 30, 2015, the Montgomery County Paralegal Association held a monthly CLE on the topic of "Personal Injury Law, Criminal Law, Litigation Procedural Issues and Ethics", presented by Carol J. Sherman, Esquire. The CLE was graciously sponsored and hosted by Mannion Prior, LLP located in King of Prussia, PA.

Carol Sherman is a Professor of Legal Studies at Peirce College where she is also the faculty advisor for the College's Legal Studies Student Association. Ms. Sherman started her legal career as an associate attorney at an insurance defense firm and later at a personal injury firm in Philadelphia. Prior to joining Peirce College, Ms. Sherman was the Deputy Managing Attorney and Pro Bono Director at Legal Aid of Southeastern Pennsylvania where she managed the Elder Law Unit. Ms. Sherman is a frequent presenter at the MCPA. Her way of delivering the material is down to earth, practical and always with a sense of humor splashed in.

At the CLE, Ms. Sherman provided an overview of some of the most significant Supreme Court cases in 2015. The discussion was very engaging and fun.

Supreme Courts cases discussed:

Walker v. Texas Division, Sons of Confederate Veterans (TSCV)

A case which poses the question whether Texas violated the First Amendment when it denied TSCV's application for a state-issued license plate with a Confederate battle flag logo, which the U.S. Court of

Appeals for the Fifth Circuit found discriminatory "against TSCV's view that the Confederate Flag is a symbol of sacrifice, independence, and Southern heritage."

Obergefell v. Hodges

On April 28, 2015, the U.S. Supreme Court heard the 6th Circuit Court of Appeals' ruling upholding discriminatory bans on marriage rights for samesex couples in Ohio and three other states. A ruling is expected by June 2015, which could bring the freedom to marry nationwide.

Glossip v. Gross

A case which challenges the use of the anti-anxiety drug to carry out executions of inmates by lethalinjection, which does not comport with the Eighth Amendment's prohibition on cruel and unusual suffering.

Rodriguez v. United States Horne v. Department of Agriculture

A case challenging the Department of Agriculture's requirement that California raisin farmers turn over a portion of their crop to the government, every year, as a prerequisite to selling the rest of their crop. The Ninth Circuit held there was nothing wrong with this scheme—which one year required farmers to give up 48% of their crop—because it was a mere "use restriction" on the sale of raisins, and therefore, not an unconstitutional taking of private property.

Another topic discussed was ethics. Ms. Sherman addressed the legal ethics issues, which arise from attorneys' and judges' use of social networking sites and the role of social media evidence in discovery and litigation.

Social media cases discussed:

Thompson v. Autoliv ASP, Inc., 2:09-CV-01375-PMP, 2012 WL 2342928 (D. Nev. June 20, 2012)



A Nevada case, where plaintiff had alleged personal injury resulting from a car accident. Defendant obtained wall messages and pictures from Plaintiff's Facebook myspace.com account to refute Plaintiff's claim of decreased quality of life after the accident. After the Plaintiff changed her account settings to make her profile private and therefore

inaccessible to Defendant, Defendant filed a formal request for information. A

Nevada court granted Defendant's motion to compel the production of the contents of Plaintiff's Facebook and MySpace accounts for last 5 years for review and identification of "discoverable" materials by opposing counsel.

Mailhoit v. Home Depot U.S.A., Inc., 285 F.R.D. 566 (C.D. Cal. 2012)

A California employment discrimination case alleging emotional distress. Defendant,

because, "in this day and age, many communications between friends and/or about an individual's emotional state are communicated via social media." The California Court noted that content posted to social networking sites is not privileged or protected, and requests for such information therefore need only be reasonably calculated to lead to admissible evidence. The court denied the defendant's motion to compel broadly-drafted discovery requests aimed at status updates, messages and pictures on Facebook. The only request, which the court approved, concerned the production of all social networking sites communications between Plaintiff and any current or former Home Depot employees, or which in any way refer to her employment at Home Depot or this lawsuit.

Other ethical issues Ms. Sherman addressed were cybersecurity, email security, and attorneys' duty to protect client information. Threats to client data are inevitable. They range from misaddressed emails to lost or stolen laptops or mobile devices, to sophisticated hacking attacks. Ethics rules require lawyers to take proactive steps to protect client information from inadvertent disclosure or unauthorized use. Consider for a moment accidentally sending a confidential email to an unintended recipient. How do you deal with this? Paralegals immediately should notify a supervising attorney under such circumstances. On the other hand, rules of professional conduct require the recipient lawyer to promptly notify the sender of the receipt of the privileged or otherwise confidential materials in order to give the sender the opportunity to take steps to protect the confidentiality of the information after its transmission.
