GUARDIANSHIPS AND HOW TO AVOID

On January 25, 2021, the Montgomery County Paralegal Association held its first meeting of 2021, albeit by Zoom. The first order of business for 2021 was to induct the 2021-2022 Board of Directors. The Honorable Stanley R. Ott (Ret) presided over the induction ceremony.

MCPA attendees were also treated to a CLE Presentation that evening given by the Honorable Stanley R. Ott (Ret) regarding Guardianships, or better yet—how to avoid Guardianships.

Judge Ott graciously supplied each attendee with a copy of the AOPC Guardianship Bench Book for Pennsylvania which he described as your "bible" for handling Guardianships in Pennsylvania. The Judge went on to explain the Guardianship should be your last resort. Guardianships are more expensive than other alternatives, there are more government regulations involved, more time-consuming, and can be very stressful to all involved. It is more important to have your family's "affairs in order" which will avoid Guardianships in the future.

Having your "affairs in order" should include: having: (a) a Will; (b) a general Durable Power of Attorney; (c) a Health Care Power of Attorney; (d) an Advanced Directive; and (e) all your financial information organized. The more information put "in order" and made known to family members, the easier it will be for the family and alleviate any surprises in the future.

Judge Ott went on to explain the differences between these documents and the importance each one relates to a person's "affairs". As those document relate to Guardianships, a current general Durable Power of Attorney is of great importance. By having this document on hand, the preparer is choosing whom they would like to assist with their financial affairs should the author be unable to handle, as opposed to Guardianships in which the Court appoints someone for you. In a Guardianship proceeding the person needing the assistance will be required to attend a hearing. Judge Ott stated that no one should want to make an elderly person attend a court proceeding and to have some stranger in a black robe decide their life. A Power of Attorney is a very powerful document and great care should be taken when preparing it. Once signed, the Agent named in the Power of Attorney has the ability to do what the author can do without limitations. The Agent should be chosen wisely, Judge Ott suggests that one person be named to its position. Parents struggle thinking they don't want to show favoritism to one child over the other by just naming one child because parents love each of their children

equally. Estate preparers should remember that individuals have different strengths and weaknesses and parents can love their children "equally," they don't have to love them "identically."

Health Care Powers of Attorney and Advanced Directives give guidance to families with regard to health care decisions. The Judge indicated that, in his opinion, the Health Care Power of Attorney is just as important as the General Power of Attorney since it is more a personal decision—it controls decisions relating to a person's overall personal health.

The evening ended with a Q&A discussion. Amongst that discussion a member of the audience raised a the topic regarding mental health and Guardianships. Mental health is a difficult topic, especially when it comes to putting your "affairs in order". The Statute on the Guardianship procedure was not meant to handle mental health disorders, such as, Bi-Polar, Alcoholism, Schizophrenia, and the like. The Mental Health Procedures Act is the Statute that is meant to assist in these matters and sometimes falls short. Judge Ott indicated that, there are many cases that come before the Orphans Court related to individuals with mental health disorders and the Montgomery County Orphans' Court handles them on an individual basis.

Judge Ott, we thank you for donating your time to share with our members this important information regarding life planning.

Information for Lawyers:

How Paralegals Can Improve Your Practice

An exert from the American Bar Associations Standing Committee On Paralegals—Information on the Profession

It's one of the most important skills in practicing law: building an effective work team to serve clients in the best possible manner and generate profits. Paralegals can be a key element in that team, especially in fostering cost efficiency. The information in this section is intended to guide you in the effective utilization of paralegals in your practice.

The Paralegal Role in the Legal Profession

What is a paralegal? A paralegal is a person, qualified by education, training or work experience who is employed or retained by a lawyer, law office, corporation, governmental agency or other entity and who performs specifically delegated substantive legal work for which a lawyer is responsible. (ABA House of Delegates, 2020)

California, has a law specifying who may use the title "paralegal," and other states, such as North Carolina and Wisconsin (PDF) are considering similar proposals. Maine, Indiana (PDF) and South Dakota have defined the terms. Maine's definition also carries fines for misuse.

Paralegals are qualified to perform their responsibilities by completing an educational program, receiving training on the job, or through actual work experience. They are not licensed as attorneys are.

Paralegals perform substantive legal work that would otherwise be done by attorneys. Clerical work is not substantive legal work.

Attorneys remain responsible for legal work delegated to paralegals and must supervise paralegals' work.

Paralegals work under the supervision of attorneys and are not "document preparers" working directly with the public.

How are paralegals regulated? Paralegals currently are not licensed as lawyers are, nor subject to any other regulatory scheme. California, however, requires a certain level of education of persons using the title "paralegal."

What is a "certified" paralegal? Technically a "certified" paralegal is a paralegal who has completed the voluntary certification process of a professional association by developing a specified level of professional competency.

NALA: The Paralegal Association awards the designation Certified Paralegal (CP) or Advanced Certified Paralegal (ACP) to persons who have met its requirements, which include passing a competency exam.

The National Federation of Paralegal Associations (NFPA) awards the designation Registered Paralegal (RP) to persons who have met its requirements, which include passing the Paralegal Advanced Competency Exam (PACE) or the designation of CORE Registered Paralegal (CRP) to persons who pass the Paralegal CORE Competency Exam (PCCE). NPFA also offers an Assurance of Learning opportunity for paralegal education programs.

NALS...the association for legal professionals, awards the Accredited Legal Professional (ALP), the Professional Legal Secretary (PLS) and/or the Certified Legal Professional (CLP), and the Professional Paralegal (PP) certification designations which reflect a proficiency in procedural law, substantive law and an overall commitment to a higher standard of conduct and professionalism. NALS' Professional Paralegals may distinguish themselves further by earning Specialty Certifications in various substantive law areas.

The American Alliance of Paralegals (AAPI) awards the designation American Alliance Certified Paralegal (AACP).

The Texas Board of Legal Specialization offers a voluntary specialty certification program in six areas of Texas law. The California Alliance of Paralegal Associations (CAPA) offers a voluntary California Paralegal Certification Program. Florida, North Carolina, and Ohio also have state-specific voluntary certification programs.

The term "certified" is sometimes mistakenly used when referring to a paralegal who has earned a certificate by completing a course of study.

The American Bar Association does not certify individual paralegals.
