RESOLUTION TO EXTEND TEMPORARY THREE-MONTH EXTENSION TO RENEW Pa.C.P. CREDENTIAL FOR AN ADDITIONAL THREE MONTHS

WHEREAS, the Keystone Alliance of Paralegal Associations (Keystone Alliance) adopted Resolution Number 2020-001 on April 8, 2020 allowing that all credentialing periods with an ending date of March 1, 2020 through December 1, 2020 shall be granted an automatic three-month extension; and

WHEREAS, the current COVID-19 pandemic and associated public safety measures continue to make it difficult for credentialed paralegals to fulfill the requirements for renewal of the Pa.C.P. credential within their designated certification periods; and

WHEREAS, the Keystone Alliance has a responsibility to address and resolve issues affecting the Pa.C.P. Program, while maintaining its integrity;

THEREFORE, The Keystone Alliance resolves as follows:

- Resolution Number 2020-001 shall be extended to cover all credentialing periods with an ending date up to March 31, 2021. No application shall be necessary to receive this extension, and there shall be no fee associated with this extension;

EXAMPLE: If your renewal date is March 1, 2021, you may submit your renewal application within 3 months thereafter, i.e., on or before June 1, 2021.

and

- This extension is being provided as an accommodation which shall not otherwise affect the Pa.C.P.'s credentialing period. Therefore, future renewal dates will not be adjusted for renewal applications submitted pursuant to this extension;

EXAMPLE: If your renewal date is March 1, 2021 and you submit your renewal application on May 27, 2021 pursuant to the renewal extension, your next renewal date will be March 1, 2023.

and



- Beginning March 1, 2021 and henceforward, any requests to extend the credentialing period shall be made by application and submitted with the appropriate fee, all in accordance with the standard policies and procedures of the Pa.C.P. Program.

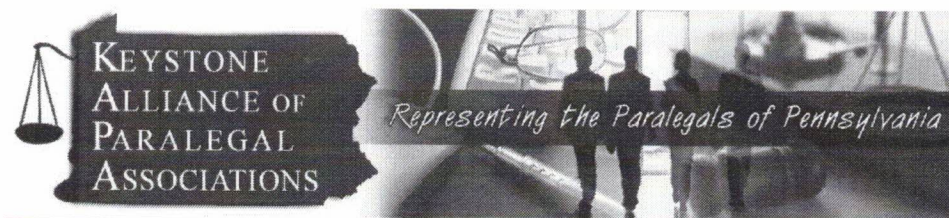

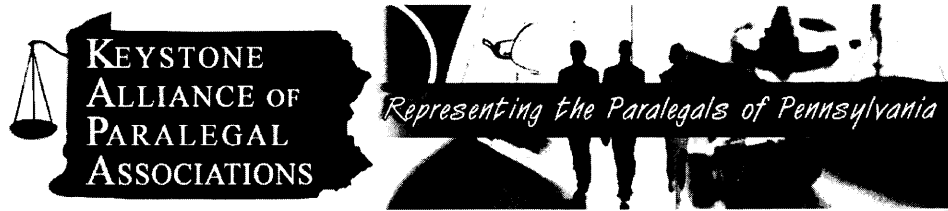

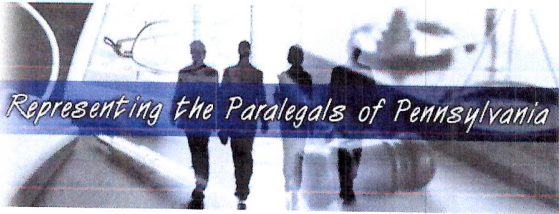
